First United Presbyterian Church Congregational Meeting Winterset, Iowa Sunday November 13, 2022 Minutes

Opened with Prayer by Rev. Dr Judy Winkelpleck @ 11:15am

- 1. Pam Deichmann is appointed Clerk Pro-Tem for the congregational meeting
- 2. Open announcements included notice of the meeting had been shared weekly in the newsletter and website for the last month. Rev Winkelpleck called for a Quorum, and it was established with 31 members present.
- 3. Paper copies of the minutes and the agenda was shared with members at the beginning of the meeting. A motion and second was received to approval for the minutes of the Congregational Meeting for January 2022, March 20 and 27 Special Meeting. Passed
- 4. Kevin De Regnier on behalf of the Property and Finance Committee presented the Proposed Budget 2023. Key points included
 - Funds left in the Easter Flower Fund,
 - Special Offering line item was included in budget
 - Note: there was still \$1030- and \$8700-dollars donation that show in the budget but anticipating there being paid out to Winterset Tornado Disaster Families in the coming weeks
 - New line item that shows increase income reflects manse rental income
 - Change in the cost of streaming license for this year
 - Budget reflects both funds for part-time pastor salary and pulpit supply fund
 - Budget submitted is a balance budget for 2023
- 5. Paul on behalf of the session gave an update that the job description for a part-time pastor was complete and posted; has interviewed one person; session has received some questions related to the position but nothing to announcement at this point
- 6. Elaine offered on behalf of the congregation a thank you to the worship team (Kevin, Paul, Connie, and Bryon) for supporting the worship service
- 7. Kevin reported the redesign of the web site included a current calendar feature
- 8. Paul on behalf of the nominating committee introduced a motion to nomination for the 2023 nomination committee of Don Stanley, Bob Kuhns, and Pat Dickerson, a second was received. Motion passed
- 9. Paul, on behalf of the nominating committee, introduced nominations for 2025 Session: Lori Ryner and Pam Deichmann for 3-year terms. Motion passed
- 10. Rev Winklepleck reminded everyone that church committee reports are due in the office Dec 18.
- 11. Rev Winklepleck called the meeting to close with a prayer @ 11:38 am

Annual Report of the Ministry of First United Presbyterian Church



2022 saw significant change in our Church's approach to ministry. We began the year with Rev. Lubbers leading the congregation's worship and ministry. At the 2022 annual meeting, it was clear things would be changing. It was at this meeting that Rev. Lubbers announced his departure as our pastor effective with the close of worship on April 24.

Beginning with the first Sunday in May, worship leadership transitioned to lay leadership from Paul Millhollin and myself and pastoral leadership monthly from Rev. Judy Winkelpleck. In November, Donna Vaughan added her gifts to the ministry team.

Ephesians 1:22-23 "And God placed all things under his feet and appointed him to be head over everything for the church, ²³ which is his body, the fullness of him who fills everything in every way."

This passage reminds us that even though we are without a called pastor, we are not alone in our journey. The church, our church, has a leader that has been with us since the beginning.

The church is not defined by who is in the pulpit on a given week, it is Christ's church. Since the founding of what we call the church, Jesus Christ has been, is, and always will be, the Head of the Church. No matter who is in this pulpit, who is visiting you, who is praying for you or with you, it is Jesus Christ who is leading. We are not without a pastor, we are not without a leader for Jesus Christ IS the head of the church.

The Session continues its search not just for A pastor, but for THE pastor God is calling to serve in this place at this time. While we would like to find that person as fast as possible, we are committed to listening for God's voice. As we know, God's timing and ours can be very different.

Psalm 27:14 "Wait for the LORD; be strong and take heart and wait for the LORD."

As we wait on the Lord to bring us together with our next pastor, the work of the church continues. We are moving forward, worshiping, caring, and teaching. More and more people are becoming involved in the ministry of the church and we are finding new ways to serve the Lord, our congregation, and our community.

One of our great joys this year has been having two ecumenical services with our brothers and sisters in Christ at St. Paul Lutheran church on Ash Wednesday and Good Friday. We also joined with First Christian, First United Methodist, and Four Square Gospel to have a joyous worship service in the park on July 4 and a community Christmas service in December. We are already planning more joint services.

As we look forward to the coming year, we are excited to see what the Lord has in store for us. For we know the Lord has plans for us.

Jeremiah 29:11-12"For I know the plans I have for you," declares the LORD, "plans to prosper you and not to harm you, plans to give you hope and a future. Then you will call on me and come and pray to me, and I will listen to you."

PROPERTY AND FINANCE COMMITTEE



The Property and Finance Committee again tackled several significant projects this past year.

The first was preparing the manse for rental. As you know, Rev. Lubbers moved out of the manse in May. Following his departure, many volunteers helped clean the manse. We then made some long needed repairs including replacing the sliding door from the kitchen to the garage. Many people also helped with a garage sale that helped cover much of the cost of the cleaning and renovations. Beginning on July 1 the manse was rented, producing needed income for the church.

The second project was not planned but resulted from wind damage to two of our air conditioning units. This damage occurred not from the tornado but from the straight winds that came through town about a week later. These AC compressors, which sit atop of the photocopier room, were blown off this roof onto the office roof. They suffered severe damage and had to be replaced. Insurance covered about half of the cost but we had to cover the \$5000 deductible and the accumulated depreciation.

Last year, one of the trees on the North side of the church died and was removed. This year we replaced the sidewalk that the roots from this tree had lifted up.

We received a wonderful surprise when Clayton Stevens donated materials and labor to tuck point the steeple and several other parts of the church. Additionally, he obtained matching slate and repaired the damaged area of the steeple, also at no cost to us. We had previously received a bid of over \$14,000 for just the tuck pointing work.

On the finance side of Property and Finance, without the expense of a pastor's salary and benefits, we have not had to sell any securities since February. Session approved and previously reported a balanced budget for 2023. That said, every year seems to bring surprises, sometimes expensive ones.

The Property and Finance Committee will continue to work to maintain our building as cost effectively as possible. Thank you for your generous support of the church and its programs.

SOCIAL MEDIA

In the past, I have reported on our website but our digital efforts now extend beyond just a static website. First United Presbyterian seeks to engage the community beyond our doors, beyond our community or even our state through our digital media use.

Our website, wintersetpresbyterian.org underwent its most extensive revision since its inception. Upon Session approval, we engaged the services of an outside company to create and deploy a modern website. This work was completed this past fall.

As a result, users will find many new features. For example, the website will automatically detect what device you are using to view the site and will scale the site for optimal viewing. The church calendar is now online and updated automatically as items are added. If you use Google calendar yourself, you can integrate the church calendar into yours. You will never miss a church event!

Other new features include direct access to important information on our home page, regularly updated content, the ability to submit prayer requests on-line, and the ability to sign up to receive the church newsletters and Steeple by email. Also prominently featured is access to our on-line giving portal.

Finally we can once again receive website usage statistics. Since mid-October, when we went live, we have had 134 unique visitors, they view an average of 2.3 pages during their time on our site, and spend an average of 3-1/2 minutes on our site. That may not seem like very much time but I believe it indicates people are able to easily find the information they want and don't have to spend a lot of time searching for it.

Our social media efforts are not limited to our website. Since 2020, we have been streaming Sunday morning worship on our Facebook page, Facebook.com/1UPCWinterset. Typically we have 5-10 people watching the service live but an additional 40 to 50 people view the service later in the week.

A special thank you to Mike Dickerson who faithfully helps ensure our service is online and professionally produced. We could use some additional people to help in the booth. If you ever come up to the sound room, it looks like a professional video production operation. We run 5 video monitors, an HDMI video switcher, a remote controlled video camera, 2 computers, 4 different computer programs, and a 32 channel sound board. While it may look complicated, it really isn't; when needed, one person can manage all of it. We will gladly provide training and promise not to leave you alone until you are comfortable. Truly, the hardest part of the job is climbing the stairs to the sound booth.

It is my goal in the coming year to expand our social media presence to include other social media channels such as Twitter and or Instagram.

Evening Guild members supported following PW Mission Projects in 2022 and local mission efforts included:


- Visited or called shut-in Feb

Supporting Winterset Tornado Disaster Families First United Presbyterian Church Winterset Iowa March 5-Dec 31. 2022 Update

The First United Presbyterian Church members actively participated in community recovery efforts in Winterset after experiencing a March 5 tornado the peaked in intensity as it traveled through Madison County with winds of 170 mph. It took six lives along Carver Road just south of Winterset and many people lost or had severe damage to their homes. Many people lost homes and personnel items across Madison and Warren Counties

Once the scope of the disaster news was widespread our church received numerous donations of disaster funds from such as Presbytery Disaster Funding, Des Moines Presbytery, and the National Congregation Church. In total funds reached over 15,000 dollars. The only request of the funds where to use the funding to assist families in their recovery efforts. Upon receiving these funds, our church started our journey to assist families.

The session appointed two members of session to work with community leaders to identify struggling families. The session members worked with community resources and were able to identify two families. Most families had received some immediate funds to assist with housing and food the first couple of weeks; but were just discovering that insurance was not going to cover the costs of recovery; or that they did not have near enough insurance; or no insurance. Families were going to have to go the long journey of recovery.

The church session received two referrals early summer; and made a commitment to assist these families thru their recovery efforts. After meeting with each family to identify their specific needs this summer, the church session created a framework in which to support the family individual recovery plan. The church assistance would come in the form of consulting, insurance expertise, emotional support and funds to assist with construction costs.

The church adopted:

Lucas Garrett family. This is a young family who lost home and outbuildings on Carver Rd; and had moved into recovery when three weeks later a windstorm blew and destroyed a trailer the family had obtained and was living in (seems like a double disaster). This family is close to meeting their recovery goals and plans and moving into their new home December 2022. The projected support was \$5000 dollars and the families have been very thankful for the additional funds and support the church has provided.

Lori and Jim Brandt (and mother) were selected because the lost a wall, trusses, and roof of the home in the disaster and found out the insurance policy they have is not going to fully fund the repair costs, only a depreciated cost. They just did not have 6000-9000 dollars to begin repairs and were trying to live in the home with tarps. This family is still trying to work though insurance and construction barriers and has a projected cost of 6000-9000 dollars; but the family is very grateful for the expertise and counselling and the church will continue to support them in the recovery efforts.
